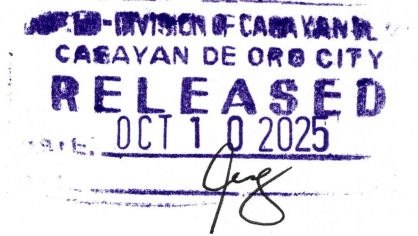

3. Immediate dissemination of and strict compliance with this Memorandum is directed.

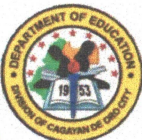

Greetings!

Pursuant to Executive Order No. 489, which mandates the Department of Health (DOH) to institutionalize the **Regional Interagency Committee on Environmental Health (RIACEH)**, we are pleased to invite your esteemed office to participate in the upcoming **Strategic Planning on Road Safety**, to be held on **October 14–17, 2025 at Deluxe Hotel, Cagayan de Oro City**.

This activity is designed to strengthen our collective efforts under the RIACEH framework by **discussing agency roles, defining deliverables, and setting timelines** for coordinated action on road safety. The Sustainable Development Goals set an ambitious target to reduce road traffic deaths and injuries by 50% by 2030. In parallel, the 8 Priority Health Outcomes of the Department of Health aim to reduce road traffic deaths to 4.0 from 8.0 per 100,000 population by 2028. Hence, the Violence and Injury Prevention Program is ramping up its road safety initiatives.

In this connection, we respectfully request your office to **designate one (1) representative** to attend the meeting, and to include your counterpart from **Iligan City and Province of Lanao del Norte**.

We kindly request you to prepare and present relevant data on your agency's accomplishments related to road safety, as well as any available information on morbidity and mortality resulting from road crash incidents. These inputs will serve as vital references in shaping our strategic roadmap.

The activity proper will start at 1pm on October 14, 2025, lunch will be served prior to start of activity and will end on October 17, 2025. Check in will be at 2:00 pm on October 14, 2025, and check out will be at 12 noon on October 17, 2025.

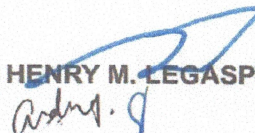
