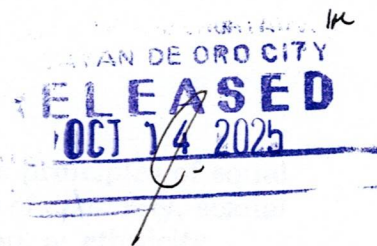

RESUMPTION OF FACE-TO-FACE CLASSES

TO: Assistant Schools Division Superintendent
All Division Office Personnel
All Elementary and Secondary Public School Heads
This Division

1. In view of Executive Order No. 0394-2025A issued by the Chief Executive of Cagayan de Oro City emphasizing the conduct of rapid post-earthquake assessment, the following guidelines are hereby issued relative to the resumption of face-to-face classes.
2. Schools inspected by the Office of the Building Official (OBO) that have received no adverse findings or feedback are encouraged to resume face-to-face classes, in accordance with the verbal instruction of the Honorable City Mayor relayed to the Schools Division Superintendent.
3. Schools with one-storey school buildings, particularly those situated in rural areas with no observable or reported structural defects based on the assessment of the School DRRM Coordinators and the School Heads, are likewise encouraged to resume face-to-face classes.
4. School managers are strongly advised to conduct Psychological First Aid (PFA) or Post-Incident Processing Sessions to provide psychosocial support for learners and personnel. These activities, to be facilitated through the Guidance Designate or Counselor, aim to ensure that learners are emotionally and mentally prepared for the resumption of face-to-face classes.
5. School Heads have to report the resumption of classes or plan thereof to **Mr. Ryan Blanco**, DRRM Coordinator, (9171545421); immediately.

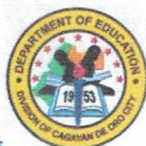
