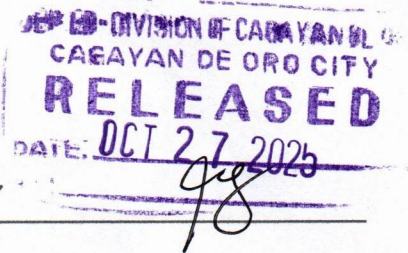

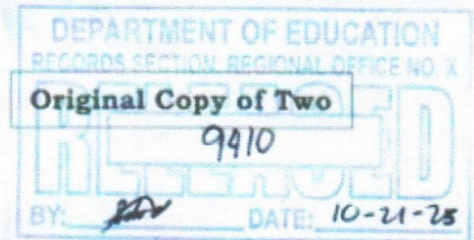

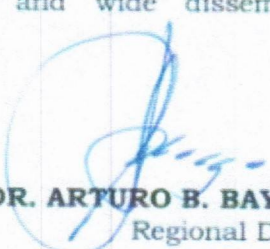
- a. November 3-6 for English, MAPEH, Values Education, and ALS
