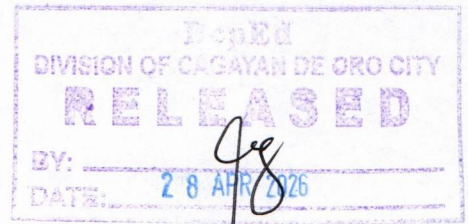

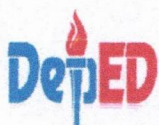

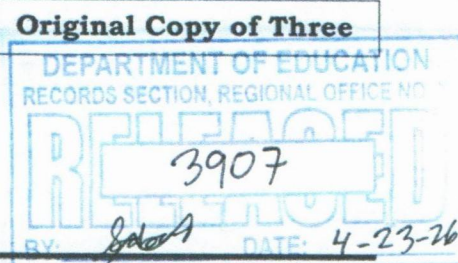

6. All Disaster Risk Reduction and Management Division Coordinators are also hereby directed to monitor and address safety and security concerns during the conduct of training in their respective divisions.

7. It is reiterated that all designations mentioned in this Memorandum shall not entail any additional remuneration from government funds.

8. In addition, all tournament directors (TDs) and assistant tournament directors (ATDs) for all concerned sporting events (attached to this memorandum) are instructed to conduct sports clinics and provide training supervision in coordination with the DSOs for the entire duration of the training. This is to ensure the provision of technical guidance, assist coaches in addressing common performance errors among athletes, and reinforce sports psychology. The transportation and other incidental expenses of the TDs and ATDs shall be charged against local funds, subject to the usual government accounting and auditing rules and regulations.
