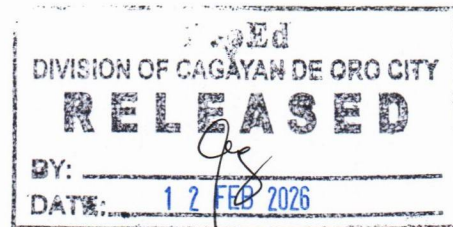

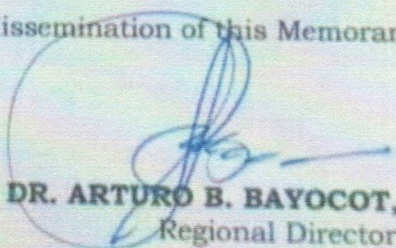

**MEASLES-RUBELLA SUPPLEMENTAL IMMUNIZATION ACTIVITY (MR-SIA)
FOR CY 2026**

To: Schools Division Superintendents
All Others Concerned

1. The Department of Health - Center for Health Development Northern Mindanao (DOH CHD-NM) will implement **Measles-Rubella Supplemental Immunization Activity (MR-SIA) for Calendar Year 2026** in Northern Mindanao from January 19 to February 13.
2. The MR-SIA aims to interrupt measles transmission through a nationwide, non-selective supplemental immunization campaign targeting children aged 6-59 months. This initiative is anchored on the current immunization performance of Northern Mindanao (Region X), which indicates persistent immunity gaps and heightened risk for measles transmission.
3. Hence, the Schools and Division Offices (SDOs) should support the activity in any of the following areas, as applicable:
 - a. Advocacy and social mobilization to increase community awareness and acceptance of MR-SIA;
 - b. Logistical or operational assistance during campaign implementation;
 - c. Mobilization of personnel or volunteers to augment vaccination teams; and
 - d. Other forms of technical, financial, or institutional support that may help ensure the success of the MR-SIA in Northern Mindanao.
