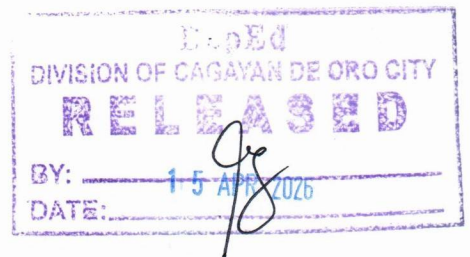

5. Expenses relevant to activity shall be charged against the SBFP Program Support Funds (PSF), subject to the usual accounting and auditing rules and regulations.

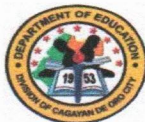
