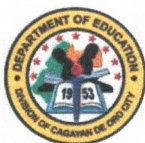

**SUBMISSION OF ANNUAL HEALTH EXAMINATION RESULTS TO SCHOOL
DISTRICT HEALTH FACILITY**

1. In reference to the issued DepEd Order No.016, s.2025, the implementing guidelines for the grant of annual medical allowance to eligible teaching and non-teaching personnel in the Department of Education and Republic Act No. 11223 that refers to Philippine Universal Health Care (UHC) law which aims to address entrenched health system challenges to achieving equitable access to quality health, the field is hereby requested to adhere in the required submission of medical health documents on **July 10, 2026** to your respective assigned school/ district health personnel and clinic in-charge.
2. These medical documents include Chest X-ray, blood chemistry results, urine examination and other needed diagnostic results taken from subsidized Health Maintenance Organization (HMO)-type benefits and YAKAP-PhilHealth sources are collected to facilitate further assessment and medical management of teaching and non-teaching personnel with risky health status.
3. All personal and sensitive information gathered shall be treated with strict confidentiality in accordance with the provisions of the Data Privacy Act of 2012- Republic Act No. 10173 and shall be used solely for the purpose intended.

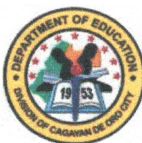
